Section 4 - First Aid Measure

Section 6 - Accidental Release Measures

Person-related Safety Precautions: Avoid causing dust. Avoid eye and skin contact.

Environmental precautions: Prevent material from reaching sewage and drainage systems or bodies of water.

Methods for Cleaning up: Use dry clean up methods that do not disperse dust into the air. With water, material hydrates to a solid harmless waste. Wear personal protective equipment. Emergency procedures are not required.
