# APPLICATION AREA

It is suitable for use on all types of masonryincluding;

- concrete brick, render and stone surfaces.
- Pebble dashing.

# SURFACE PREPARATION

- Surface should be sound, clean and free of dust, oil, grease and curing compound.
- Loosely adhered particles such as rust scale, cement smears should be thoroughlycleaned with a wire brush or another such implement.
- Concrete all new concrete surfaces must be fully cured (6-8 weeks) with a semi-rough surface appearance. Rendered surfaces must be allowed to cure for a minimum of 7 days prior to the application of Costar Repel SP.

# **APPLICATION**

- Costar Repel SP can be applied by brush, roller or low pressure spray.
- Apply the product until there is no absorptions.
- On very absorbent surfaces, wet on wet application of repeated coat is recommended.
- Application of Costar Repel SP on non-porous surfaces is not recommended.

**CONSUMPTION:** 0.5Liter per square meter per coat (depending on porosity of surface and application technique)
