DOSAGE

Typical dosage for Costarmix 730 is within the range 0.7 - 1.2 % by weight of cement.

EFFECT OF OVERDOSAGE

A dosage above the recommended level of admixture may result in high workability, slight increase in air entrainment and retardation of setting time. The ultimate strength of the concrete will not be adversely affected and will generally be higher than for normal concrete if properly placed and cured.

DISPENSING

The measured quantity of Costamix 730 should be added along with the gauging water. For best results, add Costamix 730 in the last phase after pre-wetting the mix with 80% of the total water required.

SPILLAGES _____

- Spillages of product should be absorbed onto sand, earth or vermiculite and transferred to suitable containers.
- Remnants should be hosed down with large quantities of water.
